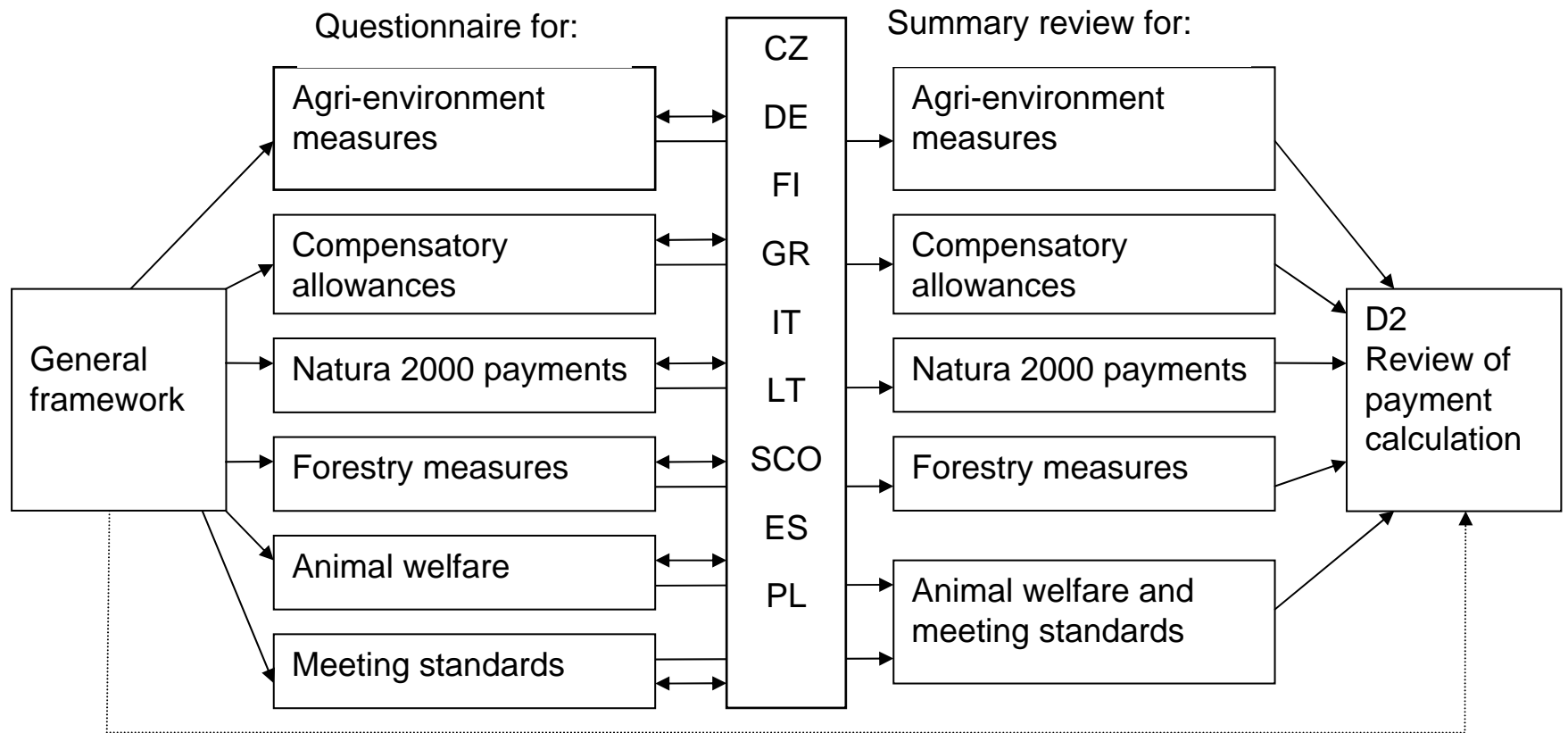


Main objectives and tasks of WP1

- to develop the general methodological framework for data collection across partner countries,
 - to coordinate the comparative analysis of the different methods for payment calculation in the selected measures within the new RDPs,
 - to determine the general structure of the five summary reviews on the payment calculation delivered by WP2-WP6 team,
 - to organize review workshop to discuss and assess the outcomes of the measure-specific reviews,
- to provide synthesis of the five reviews and summary report on review of payment calculation (Deliverable 2)



Process applied within WP1



Proposed structure of framework

I. **Basic data about the RD measure (AEM, LFA, Natura etc.)**

- overview of RD measure structure (a list of all sub-measures, level of payments, targeting, payment differentiation)

II. **Information about the methodology of the payment calculation**

- information about the methodology of payment calculation (relevant commitments, used approaches with identification of foregone income, additional costs and transaction costs)

- baseline impacts, limits of payments, interrelations between RD measures and others measures in and out RDPs, problems with payment calculation and their solutions

III. **Information about the data sources**

- type of used data sources and their availability

IV. **Contextual information**

- list of institutions involved in payment calculation
- statistical and other interesting data, remarks...



Methods for data collection

- literature reviews of key policy documents, research studies and specialized literature plus relevant grey literature and statistical data
- semi-structured interviews with key representatives of government agencies and organisations responsible for payment calculations

Barriers of investigation

- Selected RD measures are not implemented in each partner country (e.g. Meeting standards measure)
- Most of RDPs were not approved in time of data collection:
 - some information were not available
 - some changes could be expected
- By some RD measures is not possible to obtain methodology of payment calculation (e.g. mainly LFA)
 - Based on methodology valid in past – historical
 - Final confirmed payment levels are based on political decisions

List of KEY QUESTIONS for presentation

- What kind of payment differentiations exist in the partner countries?
- What cost components are considered in the calculations?
- What approaches are used to quantify the different cost components?
- Give special attention to:
 - How are costs for non-market goods derived? (e.g. costs for reduced grass yields)
 - How are costs for family labour and capital derived?
- What types of data are used in the calculations and what sources are used?
- What problems are identified in the calculations and how are these dealt with?
